- The Hawley Silk Mill is not responsible for any stolen, damaged or lost products, materials or supplies during your stay.
- You are required to supply your own chairs, tables, display boards, tarps, extension cords and tents. The Hawley Silk Mill will only be supplying you the contracted space size.
- No edged weapons or weaponry of any kind will be sold.
- No fireworks or alcohol will be brought onto the premises.
- No smoking on the premises.
- No distribution of political/campaigning material allowed.

POLICY: In the event of inclement weather management will make every reasonable effort to proceed with the event. If due to inclement weather the grounds are deemed unsafe for staff, vendors and/or festival patrons, we reserve the right to cancel the event at our sole discretion and NO REFUNDS will be given.

No refunds will be honored after December 1, 2022. To receive a refund prior to December 1, 2022 cancelation of contract must be received in writing and postmarked November 30, 2022.
